Pyle stated that he is still in negotiations with the hospital administrator on pending bills for inmates at Plains Regional Medical Center. These bills have been held since July 1, 2014 on the Safety Net Care Pool and the amount of money being sent to the state. There are 56 medical claims totaling \$169,998.36. This is based on the discounted rate the County pays for indigent patients which is 77 percent for out-patients or the Medicaid DRG if they are an inpatient.
