

40 Steve Doerr presented 2010-2011 Contract for Primary Health Care, Preventive, Dental and Educational  
41 Services to be proved to Curry County by LaCasa de Buena Salud, Inc. This is the same contract as in  
42 the past and becomes effective July 1, 2010 to June 30, 2011. The medical care and cost will be  
43 reimbursed at the rate of 77% per billed charges. The total amount of the contract shall not exceed  
44 \$350,000, with \$175,000 allotted for medical, \$150,000 allotted for dental, and \$25,000 allotted for  
45 prenatal care. **Commissioner Blackburn moved to approve the La Casa contract.** Bostwick 2nd. 3  
46 verbal ayes.


