1 **INDIGENT BURIALS**

2 Commissioner Blackburn moved to approve the claim from the Office of the Medical Investigator
3 for an indigent burial of an unclaimed person from Curry County with a date of death of May 5th,

5 Commissioner Bostwick moved to approve an indigent burial with Muffley's Funeral Home with a

8 **SUPPLEMENTAL SOLE COMMUNITY PROVIDERS FUND FOR PRMC**

9 Pyle requested approval of supplemental sole community provider funds that were released last week.
10 The hospital will receive \$587,348.34 and our portion will be \$114,591.66. This is almost a 4 to 1 federal
11 match of our indigent money, the payment is budgeted, and he recommends approval. Commissioner
12 Bostwick moved to approve the Supplemental Sole Community Providers Funds for PRMC with
13 \$114,591.66 being the counties portions contingent upon the signed contract. Blackburn 2nd.
14 Bostwick stated the hospital is putting 1.1 to 1.3 million dollars into our detention center medical
15 assistance annually without reimbursement. 4 verbal ayes.
