

**CURRY COUNTY COMMISSION
RESOLUTION 2016-57**

**A RESOLUTION DESIGNATING THREE (3) FOUR (4) DAY WORK WEEKS AND
CLARIFYING THE THANKSGIVING HOLIDAY FOR CURRY COUNTY OFFICES
DURING CERTAIN SPECIFIC DATES**

WHEREAS, the designated observed holiday's for Curry County were adopted by the Board of County Commission on October 4, 2016; and,

WHEREAS, the Board of Curry County Commission designated ten (10) holiday's where County offices will be closed for 2016 and if the Board of County Commissioners designates the same holidays for the calendar year 2017, two (2) of the federal holidays will not be taken by the County employees at the designated time; and,

WHEREAS, due to the fact that these are a federal holidays, there is confusion and some of the public assume County offices are closed when in reality, said County offices are open and on a skeleton crew; and,

WHEREAS, there are other dates where the County offices will be closed; and,

WHEREAS, to be cost effective and to assist the public during these periods, the County offices will be open for the period of time set forth hereinbelow.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Curry County, that for the specific time periods in 2017 as set forth below, the schedule for County offices shall be as follows:


1. President's Day is designated a Federal Holiday on Monday, February 20, 2017. For the week of February 20, 2017, the office hours for Curry County personnel shall be as follows:
 - a) February 20, 2017, offices are closed.
 - b) Tuesday, February 21, 2017 through Friday, February 24, 2017, the offices will be open and the hours will start at 7:30 a.m. and running through 6:00 p.m. with a 30-minute lunch on said days.
2. Good Friday is a designated holiday on Friday, April 14, 2017. For the week of April 10, 2017, the office hours for County personal shall be as follows:
 - a) Monday, April 10, 2017 through Thursday, April 13, 2017, County offices will be open from 7:30 a.m. to 6:00 p.m. with a 30-minute lunch break.
 - b) Friday, April 14, 2017 the County offices will be closed.
3. Columbus Day is designated a Federal Holiday on Monday, October 9, 2017. For the week of October 9, 2017, the office hours for Curry County personnel shall be as follows:

- a) October 9, 2017, offices are closed.
 - b) Tuesday, October 10, 2017 through Friday, October 13, 2017, the offices will be open and the hours will start at 7:30 a.m. and running through 6:00 p.m. with a 30-minute lunch on said days.
4. The Thanksgiving holiday will be November 23, 2017 and November 24, 2017. For the week of November 20, 2017, the office hours for County personnel shall be as follows:
- a) On Monday, November 20, 2017 and Tuesday, November 21, 2017, the County offices will be open and the hours will be 8:00 a.m. and running through 6:00 p.m. with a 30-minute lunch on said days.
 - b) On Wednesday, November 22, 2017, the County offices will open at 8:00 a.m. and will close at 1:00 p.m. County offices will be closed from 1:00 p.m. to 5:00 p.m.
 - c) County offices will be closed all day November 23, 2017 and November 24, 2017

NOW, THEREFORE, BE IT FURTHER RESOLVED that this Resolution only addresses the four (4) specific weeks set forth and identified hereinabove. Nothing in this Resolution shall pertain to any other calendar, work schedule or arrangements established by the Board of County Commissioners of Curry County pursuant to other resolutions or ordinances.


