

**CURRY COUNTY
RESOLUTION #2014-48**

**A RESOLUTION INCREASING THE SALARIES
OF ELECTED OFFICIALS IN CURRY COUNTY, NEW MEXICO**

WHEREAS, the salary for elected county officials is established by statute; and,

WHEREAS, the Board of County Commissioners of Curry County, on July 24, 2012, adopted a resolution increasing elected officials' salaries by three percent (3%). Thereafter, on July 26, 2013, the Board of County Commissioners of Curry County adopted a resolution increasing elected officials' salaries by four percent (4%); and,

WHEREAS, the salaries of the Curry County elected county officials at the present time are below the statutory limit pertaining to the same; and,

WHEREAS, the current salaries of Curry County Elected Officials pursuant to the 2013 Resolution are:

- 1) Effective January 1, 2015, the salary for Sheriff will be \$56,247.17; Assessor will be \$53,933.44; Probate Judge will be \$18,872.53; and Commission District 1 and District 3 shall be \$21,503.02.
- 2) Effective January 1, 2017, the salary for Clerk will be \$53,933.44; Treasurer will be \$53,933.44; Commission Districts 2, 4 and 5 will be \$21,503.02; and,

WHEREAS, it is the desire of the Board of County Commissioners of Curry County, which is the governing body thereof, to raise the salaries for the elected officials in Curry County an additional ten percent (10%) effective January 1, 2015.

BE IT HEREBY RESOLVED by the Board of County Commissioners of Curry County, pursuant to state law that the salaries to be paid to elected officials in Curry County shall be as follows:

- 1) Effective January 1, 2015, the salary for Sheriff will be \$61,871.89; Assessor will be \$59,326.78; Probate Judge will be \$20,759.78; and Commission District 1 and District 3 shall be \$23,653.32.
- 2) Effective January 1, 2017, the salary for Clerk will be \$59,326.78; Treasurer will be \$59,326.78; Commission District 2, 4 and 5 will be \$23,653.32.

BE IT FURTHER RESOLVED that no salary increase shall take effect until the first day of the term of an elected county official who takes office on or after January 1, 2015.
