RESOLUTION NO. 2014-65

DECLARING THE INTENT OF THE BOARD OF COUNTY COMMISSIONERS OF CURRY COUNTY, NEW MEXICO, TO CONSIDER FOR ADOPTION AN ORDINANCE AUTHORIZING ISSUANCE AND SALE OF UP TO \$15,000,000 CURRY COUNTY, NEW MEXICO GROSS RECEIPTS TAX IMPROVEMENT REVENUE BONDS FOR THE PURPOSE OF CONSTRUCTING, PURCHASING, FURNISHING, EQUIPPING, REHABILITATING, MAKING ADDITIONS TO OR MAKING IMPROVEMENTS TO ONE OR MORE PUBLIC BUILDINGS OR PURCHASING OR IMPROVING GROUND RELATING THERETO; AND DIRECTING THE COUNTY MANAGER TO PUBLISH NOTICE OF INTENT TO CONSIDER SUCH ORDINANCE IN A NEWSPAPER OF GENERAL CIRCULATION WITHIN THE COUNTY.

WHEREAS, Curry County, New Mexico (the "County") desires to consider for adoption an ordinance authorizing issuance of up to \$15,000,000 Hold Harmless Gross Receipts Tax Improvement Revenue Bonds (herein, the "Bonds") to provide funds for constructing, purchasing, furnishing, equipping, rehabilitating, making additions to or making improvements to one or more public buildings or purchasing or improving ground relating thereto (herein, the "Project"); and

WHEREAS, Section 4-37-7 NMSA 1978, requires that publication of the title and general summary of this subject matter of any proposed ordinance be made in a newspaper of general circulation within the County at least two weeks prior to the meeting of the Board of County Commissioners at which the ordinance is proposed for final passage.

BE IT RESOLVED BY THE COUNTY COMMISSION, THE GOVERNING BODY OF THE COUNTY OF CURRY:

Section 1. That all action (not inconsistent with the provisions hereof) heretofore taken by the County Commission of Curry County and the officers thereof directed toward the Project and the authorization and issuance of the Bonds therefor, be and the same is hereby ratified, approved and confirmed.

Section 2. That the County Manager is hereby directed, in accordance with Section 4-37-7 NMSA 1978, as amended, to publish in the *Clovis News Journal*, a newspaper of general circulation within the County, a title and general summary of the ordinance relating to and authorizing issuance of the Bonds at least two weeks prior to the meeting at which the County Commission will consider such ordinance. The County


Manager may undertake such publication upon his own initiative and submittal of any necessary documents related to the proposed ordinance.

Section 3. That the County Manager is hereby directed to take any necessary action in connection with the issuance of the Bonds, including preparation of disclosure documents and required publications.


Section 4. This Resolution shall take effect immediately upon its adoption and approval.




