**A RESOLUTION  
AUTHORIZING BUDGETARY ADJUSTMENTS AND REVISIONS**

**WHEREAS**, the Board of Commissioners of Curry County meeting in session on December 17, 2013 did propose to make budget adjustments and revisions; and

**WHEREAS**, the County of Curry does, through Budget Resolution 2013-53, ask that authorization for the budgetary adjustments and revisions be granted, as summarized in the attached sheet; and

**WHEREAS**, the County of Curry wishes to increase revenue and expenses in the State of New Mexico Local DWI Fund by \$47,598.44 This amount reflects funds reverted back to the State of New Mexico Local DWI Grant from Fiscal Year Ended June 30, 2013. These funds were reapplied for and awarded during Fiscal Year 2014.

**NOW, THEREFORE**, the Board of Commissioners of Curry County does hereby approve the aforementioned budget adjustment(s), and

**NOW, THEREFORE**, it is respectfully requested that authorization for the budgetary adjustments and revisions be granted by the Local Government Division of the Department of Finance and Administration of the State of New Mexico.



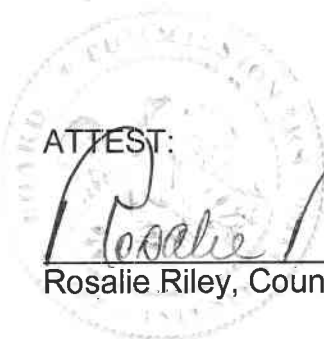


