6 **1. Request Action on Contract for Primary Health Care, Preventive and Dental Services**  
7 **with La Casa de Buena Salud – Lance A. Pyle**

8 Pyle noted the contract for healthcare, preventative and dental services with La Casa that  
9 references the County to pay 72% of the billed charges and agrees to forgive the balance due  
10 from the patient. The period is from July 1, 2018 to June 30, 2019; \$50K is allocated with \$2K  
11 for medical services and \$48K for dental services.

12 **2. Request Action on Contract for Primary Healthcare and Preventive Services with**  
13 **Roosevelt General Hospital/Clinic for the Melrose Health Clinic – Lance A. Pyle**

14 Pyle noted the contract with Roosevelt General Hospital that references funds to provide  
15 primary healthcare and preventive services for indigent residents of Curry County for services  
16 rendered at the Melrose Health Clinic and states the County to pay 72% and the remainder  
17 being written off for a period from July 1, 2018 to June 30, 2019 in the amount of \$1,100.
