**3. Discussion and Request Approval of Second Amendment to Contract For Primary Healthcare, Preventative, Dental and Educational Services with La Casa - Lance A. Pyle**

Pyle said the original contract with La Casa was for \$300,000. Earlier this year we increased that by \$25,000 to provide more money for dental. This second amendment is an additional \$25,000 to the contract, which brings the total contract amount for the 2012/2013 fiscal year to \$350,000. If the additional \$25,000 is approved today, it will be allotted to dental. **Motion to Approve the Amended Contract.** Bostwick asked if the Indigent Fund would still get us to the end of the year for primary care, and Pyle said through the end of the fiscal year ending June 30, we have enough to pay all the obligations that are out there.
