50 **4. Discussion and Request Approval of Contract for Primary Health Care, Preventive, and Dental Services with La Casa – Lance A. Pyle**

51 Pyle presented Commission with Contract for Primary Health Care, Preventive and Dental Services. Pyle stated copy of contract in meeting agenda packet had 2 typos which will be corrected: 1) Sixth paragraph of document states 'RGH'-will be revised to state 'La Casa'. 2) Under Scope of Services, second to last sentence states 'Melrose Health Clinic,' and will be

1 revised to 'Clovis Health Clinic'. Pyle pointed out county previously paid La Casa at 77%, but
2 recommended lowering to amount to 72% for the next fiscal year due to Indigent Budget. Term
3 of contract is July 1, 2017- June 30, 2018. Reduced amount from \$70,000 from the prior Fiscal
4 Year to 65,000; allocated \$63,000 for dental, and \$2,000 allocated for medical. Pursuant to this
5 contract, the claims are paid from Indigent Fund, but 99% of residents seen at La Casa are
6 residents of the City of Clovis.

15 Pyle presented proposed contract with Roosevelt General Hospital for the Melrose Health
16 Clinic. Pyle pointed out previously paid La Casa at 77%, recommended lowering to 72% for the
17 next fiscal year due to Indigent budget. Term of contract is July 1, 2017 – June 30, 2018.
18 Reduced amount from \$4,000 from previous fiscal year to \$2,500.
