Past/New Business

- DWI Grant and Distribution Allocation FY2020 (*Doria Rey*)
 - Estimated Distribution Total = \$221,586
 - Competitive Grant Award Total = \$75,000
 - Will be used for Treatment, Domestic Violence Treatment and partial Compliance salaries
- Juvenile Adjudication Fund Grant Application due May 24, 2019 (*Doria Rey*)
 - Use these funds for the different Teen Court curriculums we use as sanctions for the kids
- Still waiting on Duane Chase from Sir Logo regarding the billboard
- Due missing Chairman not being at this meeting, tabled nominations / elections for Vice Chair until next meeting
- Report on DEA Take Back Event (*Tanya Henderson*)
 - On April 27, 2019, Curry County OSAP collaborated with community partners on DEA Take Back Events
 - U. S. Drug Enforcement Administration initiative that gives the public an opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous, expired, unused, and unwanted prescription drugs. No questions asked and free of charge
 - Considerable involvement from the Sheriff's Office, State Police and City Police
 - Had two sites this year, Walgreens and Roden Smith Pharmacy
 - Collected 109 pounds at these events, considerably more than the 56 pounds we collected at the last event
 - Will be holding another DEA Take Back on Saturday, October 27, 2019
 - We were not advertising to take needles, but Roosevelt County did, so there was some confusion, as long as the needles are in a sealed container we are able to take them, and we will clarify for the next event in October, and we will have a sharps container available
- Report on Annual Spring Break Day Camp (*Oriana Riley*)
 - March 26 – 28, 2019
 - 18 participants
 - Discussed topics we believed would be important for kids to understand including: community engagement, diversity, healthy interactions
 - Hopefully again next year
 - Texico couldn't participate because their Spring Break is at a different time
