Good morning Shelley: Please see the proposal link below detailing our billboard locations in Clovis, NM. The proposal includes a list of available boards along with photo sheets of each individual unit.

Our four week 'Proposed Net Rates' are based on the purchase of one board for one year; if you purchase 2 or more, I can reduce your four week rate to \$225 each on an annual contract. If you choose to advertise for less than a year, a 10% increase in rates quoted will apply, with a minimum contract term of 12 weeks.

Our vinyl print and install is at \$2.25 per sq. ft. or \$675 for our 12'x25' size billboards. The vinyl is guaranteed for one year and we gladly assist with design service if needed. Please add tax of 7.8333% to all billing.
