**CURRY COUNTY BOARD OF COUNTY COMMISSION**

**A RESOLUTION ESTABLISHING THE 2021 HOLIDAY SCHEDULE  
FOR COUNTY EMPLOYEES**

**WHEREAS**, New Mexico statutes, § 12-5-2, NMSA 1978 as amended, establishes the legal holidays for New Mexico governmental entities; and,

**WHEREAS**, the Board of County Commissioners of Curry County, in reviewing the Calendar for the year 2021 and pursuant to §12-5-2, NMSA 1978, desires to establish by this Resolution, the holiday schedule for County Employees.

**NOW, THEREFORE, BE IT HEREY RESOLVED** by the Board of County Commissioners of Curry County that the below listed schedule of holidays is adopted for all Curry County Personnel for the Calendar year 2021.

| President's Day                   | will be observed on Friday-   | November 26, 2021 |
| Christmas Eve                     | will be observed on Friday-   | December 24, 2021 |
| Christmas Day                     | will be observed on Monday-   | December 27, 2021 |

These holidays are for eight (8) hours and three point five (3.5) hours on November 24, 2021, a total of ninety-one point five (91.5) hours. If the employee works a flexible schedule of ten (10) or twelve (12) hours, the employee will only receive eight (8) hours on each holiday and will need to adjust schedule with Department Head or take annual leave or compensatory time to make up the same.

Pre-Thanksgiving departure time will be Wednesday, November 24, 2021. Curry County offices will close at 1:30pm. No County offices will be closed for lunch and all County employees will be required to work five point five (5.5) hours on November 24<sup>th</sup> or they will be required to take leave time and deduct the hours from their accrued annual, personal or compensatory time.




